## ACA Implementation Resources for Pediatricians in Louisiana

On October 1, 2013, open enrollment for individuals and families to sign up for health insurance in the new Affordable Care Act (ACA) marketplaces (formerly known as exchanges) will begin. The marketplace will allow people to compare and choose which type of health insurance plan will work best for their families. Public health insurance programs like Medicaid and the Children's Health Insurance Program (CHIP) are still available before, during, and after open enrollment, and one streamlined application will make it easier to for people to find out which plan will best meet their needs.

## New AAP Resource for Parents and Families of Patients

Making sure families are aware of the options available to them for pediatric patients through the marketplaces and what to look for in their insurance plans is extremely important. To help pediatricians assist their parents and families of patients navigate the marketplaces, the AAP has created state specific documents just for families. Every state, regardless of whether your marketplace is being managed by the state or federal government, has its own document with information regarding the marketplace. ## Changes to Medicaid Eligibility Criteria Effective 1/1/2014

Effective January 1, 2014 some Medicaid eligibility programs will change:

## LaMOMs (pregnant women)

Income limits for pregnant women eligible for LaMOMs will reduce from up to 200 percent of the Federal Poverty Level (FPL) to 133 percent. This will not affect anyone whose application is received prior to January 1, 2014. Those who are currently enrolled will continue to get coverage through the end of the second month following the end of their pregnancy. Applications received on or after January 1, 2014 will be evaluated based on the new guidelines. Changes to Medicaid Eligibility Criteria Effective 1/1/2014 cont'd.

## Medicaid Purchase Plan (working individuals with disabilities)

Income limits for individuals eligible for MPP, often referred to as the "Ticket to Work" program for working people with disabilities, will reduce from 250 percent FPL to 100 percent. Income and resources for spouses, previously not

considered to determine eligibility, will count beginning January 1, 2014. Also, the resource limit will reduce from \$25,000 to \$10,000, and all life insurance policies, medical savings accounts, and retirement accounts will no longer be disregarded. DHH anticipates this change will affect nearly 1,200 individuals enrolled in the program, with 700 of that number having Medicare coverage as their primary insurance.

## **Disability Medicaid**

The Disability Medicaid program, which was implemented in 2007, currently provides coverage to individuals 65 or older, or that meet the disability requirements as defined by the Social Security Administration (SSA), and whose income is below the Supplemental Security Income (SSI) program limit (currently \$730 per month for an individual). On January 1, the Disability Medicaid program will end.

Individuals, who receive SSI cash benefits, are automatically enrolled in Medicaid. Therefore, the more than 9,200 individuals currently enrolled in the Disability Medicaid program are urged to apply for SSI as soon as possible. If these individuals are not determined to be eligible for SSI, or another Medicaid program, by January 1, they will no longer receive Medicaid effective December 31, 2013.

Applicants who apply for Medicaid on or after January 1, 2014 will be referred to SSI if the applicant appears to meet the eligibility criteria for SSI.

## **Other Healthcare Options**

Subsidized health insurance will be available to individuals at or above 100 percent FPL, who no longer qualify for Medicaid, through the Federal Health Exchange created through the Affordable Care Act (ACA). Open enrollment for assistance with health care coverage through this marketplace begins October 1, 2013, with coverage available January 1, 2014. ## Louisiana Improves in Annual Federal Breastfeeding Rankings, Improves Rate of Breastfeeding in Infants to more than Sixty Percent

## Health Department Celebrates Improvement, Emphasizes Benefits to Moms, Babies During World Breastfeeding Month

**BATON ROUGE, La.** - Louisiana jumped four spots in the federal government's latest breastfeeding report card, marking solid progress in the state's support of breastfeeding, the Department of Health and Hospitals announced Thursday. Breastfeeding has been proven to improve health outcomes for women and children, including reducing the rate of childhood obesity.

In total, more than 60 percent of infants in Louisiana have been breastfed at some point in their lives, up from 53 percent last year. This improvement, attributable to efforts by the DHH and its partners to promote breastfeeding, helped Louisiana move up to 44<sup>th</sup> on the Centers for Disease Control and Prevention's 2013 Breastfeeding Report Card, released this week.

The improvement coincides with World Breastfeeding Week, and DHH officials are reminding everyone that breastfeeding can contribute to the long-term health of women and their children. Gov. Bobby Jindal proclaimed August as World Breastfeeding Month in Louisiana as part of an international effort to raise awareness about the many benefits of breastfeeding and the important role that community plays in supporting breastfeeding.

"Whether to breastfeed is one of the first decisions we make as parents, and it's also one of the most important because it can impact a child's lifelong health. I am proud that we have improved the rate of breastfeeding in our state, which is a key factor in reducing future problems like childhood obesity and diabetes," said DHH Kathy Kliebert. "It is so important for parents, especially first-time mothers, to have all the facts about the ways in which breastfeeding can improve their child's health. Every child deserves the best chance at a healthy future, and we want parents to know there are resources available to help."

"I applaud Louisiana's hospitals, the breastfeeding support community and our DHH employees for the outstanding job they have all done in championing this worthwhile cause," said J.T. Lane, assistant secretary for Public Health. "Breastfeeding is the most nutritious way to feed your baby, and it acts as a protection against chronic disease later in life including reducing childhood obesity."

The 2013 theme, "Breastfeeding Support: Close to Mothers," focuses on Breastfeeding Peer Counseling. Even when mothers are able to get off to a good start, all too often in the weeks or months after delivery there is a sharp decline in breastfeeding rates, and practices, particularly exclusive breastfeeding.

The Peer Counseling Program provides an essential support system for mothers to help meet their breastfeeding goals and to maintain. Peer counselors provide a valuable service to their communities, addressing the barriers to breastfeeding by offering breastfeeding education, support and role modeling. They are mothers, many recruited by the Louisiana Women, Infants and Children Program (WIC), who have personal experience with breastfeeding and are trained to provide basic breastfeeding information and support to other mothers with whom they share various characteristics, such as language, race/ethnicity, and socioeconomic status.

Louisiana's rate of infants who are ever breastfed is 60.6 percent, compared to the national average rate of 76.5 percent, according to the Centers for Disease Control and Prevention's 2013 Breastfeeding Report Card. Louisiana also has lower-than-national-average rates of infants who are exclusively breastfed at three months and six months, and lower rates of infants who continue breastfeeding through 12 months.

Some positive health outcomes mothers and babies experience from breastfeeding, continued at least for the first six months of the baby's life, include:

- Increased natural immunity and lowered risk for babies of infections and stomach problems, allergic reactions, asthma and Sudden Infant Death Syndrome (SIDS).
- Reduced risk of babies becoming obese or developing diabetes later in life. Breastfeeding may also reduce the mother's risk of certain breast and ovarian cancers and Type II diabetes.
- Increased opportunity for the mother to relax and develop a special bond with her baby.

Greater weight reduction for mothers who breastfeed because they lose pregnancy weight faster. They also have an opportunity to save more money than mothers who don't breastfeed because they don't have to buy formula, bottles and other feeding supplies.

The DHH's Office of Public Health is using this month to raise awareness of the benefits of breastfeeding and promote key statewide activities and initiatives that are under way to improve Louisiana's rates of breastfeeding.

"Breastfeeding is good for both the mother and the baby," said Dr. Takeisha Davis, DHH Office of Public Health Chief Medical Officer. "This month, we want to let Louisiana moms know there are programs and services available to support them and their entire family so they can give their infants a better start at a healthy life by choosing to breastfeed."

## Supply update on Daptacel, Pentacel, Adacel and Act-Hib Vaccines

**TO**: Vaccine For Children Providers

SUBJECT: Supply update on Daptacel, Pentacel, Adacel and Act-Hib Vaccines.

We wanted to give you an update regarding the supply of Sanofi's pertussis-containing vaccines: Daptacel (DTaP), Pentacel (DTaP-IPV-Hib), Adacel (Tdap) and Act-Hib(HIB-PRP-T). This update provides information about the expected supply of these four vaccines between mid-August and mid- October of 2013, which will be lower than previously anticipated due to the delayed release of new vaccine lots. This delay resulted from an anomaly identified during a routine test procedure of one of the filling lines, and it affects all products filled from that line.

Daptacel: Supplies will be limited during the remainder of August, and there will be no additional distribution during the month of September or the first half of October.

Pentacel: As previously communicated, CDC did not allocate additional doses for the month of August. This message extends the time period during which no additional doses of Pentacel will be available to include the month of September and the first half of October.

Adacel: Supplies for the remainder of August, September, and October are anticipated to be limited, though doses will continue to be available.

Act-Hib: Supplies will be limited during the remainder of August, and there will be no additional distribution during the month of September or the first half of October.

Fortunately, CDC has confirmed that GSK will be able to increase its supply of pertussis-containing vaccines to be able to address gaps related to the supply limitations described above. This means that the availability of pertussis-containing vaccines will be sufficient to support the routine vaccination schedule for children, adolescents, and adults. Also, other presentations of DTaP and Hib are available.

Of note, Sanofi is implementing/has implemented controls for all four of these products for their private sector orders as well.

The announcement states that they will provide a potential roadmap for how Louisiana will move from the pilots to full-scale implementation in 2015-16. The roadmap will highlight each key work stream for achieving a statewide system, indicating when aspects of the system will be established.

The announcement further notes that they will tour the state discussing the roadmap and seeking feedback on their plans to establish a unified early childhood system. The release of the roadmap and launch of the statewide engagement tour will be held as follows:

## **SUIDA Recipe- Firecracker Smashed Potatoes**

Crispy smashed potatoes are the best of both worlds, delivering mashed potato creaminess with the crackling crisp crust of roasted potatoes. Add nutrient rich light Jalapeno Cheddar Cheese and make an ordinary side dish pop like the Fourth of July. Bring excitement and nine essential vitamins and minerals like calcium, potassium and vitamin D to your dinner table!

## Ingredients

- 1 whole head garlic, top trimmed
- 1 teaspoon olive oil
- 3 pounds Idaho or russet potatoes, scrubbed
- pinch of Kosher salt
- 8 ounces Cabot 50% Light Jalapeno Cheddar cheese, grated
- 2 tablespoons chopped canned chipotle peppers in adobo sauce

canned sliced jalapeno peppers for garnish

## **Directions:**

Preheat oven to 350 degrees Fahrenheit. Put garlic head on large square of aluminum foil and drizzle with oil. Gather foil around garlic, twisting top to close tightly. Bake 60 minutes or until pulp is golden and very soft. When cool enough to handle, break apart cloves and squeeze pulp from each into small bowl; mash to puree with fork.

In large pot of boiling, salted water, cook potatoes until tender, about 20 minutes. Drain well and return to pot. Add cheese, chipotle peppers and garlic puree. Mash to combine, leaving potatoes very chunky. Garnish with jalapeno peppers.
