This was another very busy week for both the House and Senate Health and Welfare Committees. The chapter has sent out several action alerts over the last few weeks. Thank you to everyone who took the time to reach out to the legislators on the committees. It is vital that they hear from providers. Next week will be another busy week on the healthcare front. Several bills were passed out of committees this week and will likely be heard on the full floor in their chambers. This is another point during the process to make a difference. Please read the Call to Actions that follow and take a few minutes to act.

House Floor action:

HB 1065, Representative Pope's optometrist bill, was heard on the House Floor and passed by a vote of 66 yeas and 30 nays. There were a number of amendments offered during the discussion but each was either rejected or withdrawn. The bill now goes to the Senate committee for debate and consideration.

HB 1, the state's budget bill, was debated on the House Floor on Thursday, May 8, 2014. The state budget bill was passed off the House Floor by a vote of 65-34. There was an amendment by Representative Walt Leger, III which restored funding and reversed the planned implementation of a triage rate for non-emergency use of emergency rooms and to reverse the planned implementation of a reimbursement rate for sub-acute care. This amendment passed without objection.

House Committee on Insurance:

HB 711, by Representative Hunter Greene which would have required health plans to collect a co-insurance and deductibles was discussed during committee but was voluntarily deferred.

Senate Health and Welfare Committee action:

SB 497, Senator Heitmeier's balanced billing bill, was deferred in committee and was not heard for the fourth time. It is expected to be on next week's agenda as well. There are several other balanced billing pieces of legislation that have not been scheduled yet.

SB 754 by Senator Moreno passed favorably out of committee with no objections. This bill allows first responders to carry naloxone.

Senate Floor action

SB 600, Senator Mills' vaccine bill, was amended on the House Floor. The amendment requires that "At the time that a pharmacist administers an immunization or vaccine under the provisions of this Section, the pharmacist shall also inform the individual that the administration of an immunization or vaccine under this Section is not to be construed as being in lieu of an annual checkup with the individual's primary care or family physician." With this amendment, the bill passed favorably off the Senate Floor by a vote of 23 yeas and 13 nays. The bill now goes to the house committee for debate and consideration.

Thank you to everyone who has written or called their Senator and committee members. Your voice makes a difference. The Chapter will continue to keep you up to date as this bill moves through the process.

SUIDA Recipe - Bow Tie Pasta Salad

Bow Tie Pasta Salad

Pasta salad is a dish that can be as individual as the cook themselves, a light summer pasta dish is sure to compliment any meal. Adding low fat cheddar cheese infuses nine essential vitamins and minerals into this picnic and potluck favorite. Make it sparkle with fresh and tasty mix-ins and add dietary fiber by choosing whole wheat pasta.



Ease: Moderate

Prep time: 15 min

Cook time: 15 min

Yield: 8 servings

Ingredients:

1 (8-ounce) box bow tie or other shaped pasta

1/3 cup light mayonnaise

2 tablespoons cider vinegar

2 tablespoons sweet pickle relish

1/4 teaspoon ground white pepper, or to taste

1/8 teaspoon hot pepper sauce, or to taste

4 ounces reduced-sodium baked ham or smoked turkey, diced

8 ounces reduced-fat Cheddar cheese 1/2 medium red pepper, finely chopped

2 scallions, green and white parts, minced

1/8 teaspoon paprika

Directions:

Cook pasta according to package directions, drain. Immediately rinse with cold water, drain well.

Meanwhile, whisk together the mayonnaise, vinegar, relish, white pepper and pepper sauce in a small bowl; set aside in the refrigerator to chill.

Combine the cooled pasta, ham, cheese, red pepper and scallions in a large bowl. Stir in the mayonnaise mixture just before serving. Garnish with paprika.
