Screening Tools for Adolescent Substance Use

NIDA Launches Two Brief Online Validated Adolescent Substance Use Screening Tools

NIDA has launched [two brief online screening tools](#) that providers can use to assess for substance use disorder (SUD) risk among adolescents 12-17 years old. With the American Academy of Pediatrics recommending universal screening in pediatric primary care settings, these tools help providers quickly and easily introduce brief, evidence-based screenings into their clinical practices.

Implications of the Score and Overall Risk Level

Adolescents reporting substance use in the past twelve months with these frequencies are at higher risk of meeting diagnostic criteria for a substance use disorder (SUD), although not all who report at this level meet criteria. This result, with co-occurring declines in academic, social, or family functioning, may indicate a higher problem severity. In a small validation study, patients reporting weekly use or greater were categorized at a higher risk

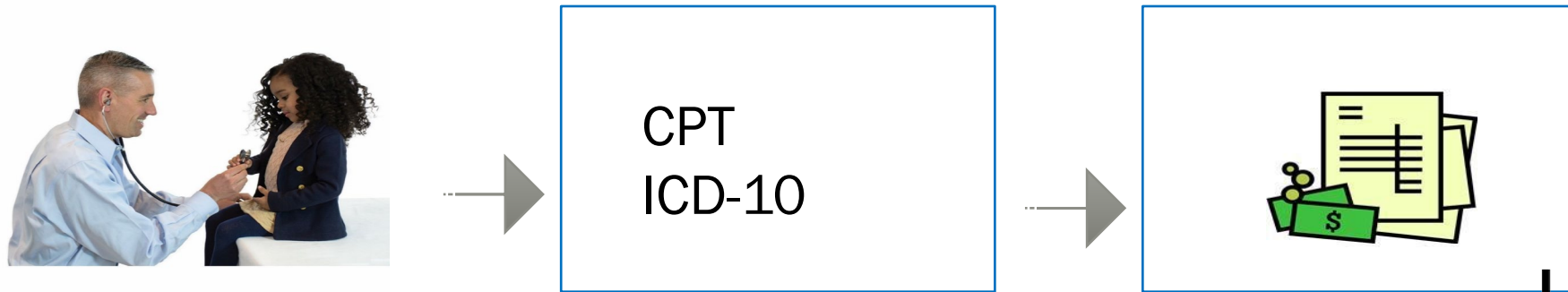
Understanding Privacy and Confidentiality

Privacy refers to the individual; Confidentiality refers to their information

Privacy=the provider's **responsibility** to keep the individual's information private

Confidentiality= the patient's **right** to determine how that info is shared

Billing and coding provide a translation from services rendered to payment

Consent to Medical Care in Louisiana (lsu.edu)

- **Minors**
- Louisiana allows minors to consent to their own medical care without telling their parents. This includes care for pregnancy and childbirth, and sexually transmitted infections. (There are special rules about abortion and sterilization.) The statute does not set a lower limit on the age of minor who may consent, and there is no case law that sets a minimum age of consent. Physicians are protected from liability for relying on the consent of a minor.
- If you are a minor, the doctor is not required to tell your parents or guardian about your care, but may tell them if this is in your best interest, even if you do not want them told. If your parents disagree with you about your care, their decision is final.
- Parents can consent to the care of their minor children, even if the parent is a minor.
